EXPLORATION PERMITS FOR COAL GRANTED

Pacific Enviromin Limited (“PEV”) is pleased to announce that a further three Exploration Permits for Coal have now been granted. This brings the total number of granted EPC’s held by the company through its subsidiaries Mining Investments One Pty Ltd and Area Coal Pty Ltd to seven.

A further seven tenements are expected to proceed to grant, four following completion of Native Title processes. Eighteen more EPC applications await processing, nine of which are competing. The table below sets out the status of each EPC and EPC application held by PEV.



The philosophy of PEV's management has been to secure strategic tenure by identifying available tenements close to operating mines or in areas with proven or potential in-ground resources in regions suitable for short term development.

An initial review of the projects identifying prospective areas for further exploration has been completed and the Company is focused on exploiting the commercial value of the projects. The Company's geologists are identifying exploration targets in each of the project areas and are preparing proposals for further exploration of the target areas to enable the Company to define the mineral resource.

Exploitation opportunities include one or a combination of farm-in, joint venture development or joint venture exploration. It is expected that a number of development opportunities will arise from these strategic holdings.

The first of these opportunities has been realised with the Company has entering into a Joint Venture Exploration and Development Heads of Agreement with Blackwood Resources Pty Ltd. The agreement covers four of the tenements listed in the above table. Further details are contained in PEV's earlier ASX announcement of 6 April 2010.
