During the quarter a rights issue of ordinary shares jointly underwritten by Patterson Securities and Cygnet Capital raised \$3.2 million and was completed on 28 July 2008.

Subsequently the Company purchased loaders and plant to commence on-site processing of calcium bentonite at Mantuan Downs. Product is being shipped from the mine in bulk and bagged.

Field trials under agreements with various agricultural companies have proceeded successfully with reports of significant improvement in growth rates for produce, and enhanced moisture retention in the soil.
